The progress of the Coalition was described in two publications (Toxicologic Pathology 37:359-360, 2009, and Veterinary Pathology, 46:565-566, 2009) and a poster was presented at the American College of Veterinary Pathologists Annual Meeting that was held during December 2009 in Monterey, California
