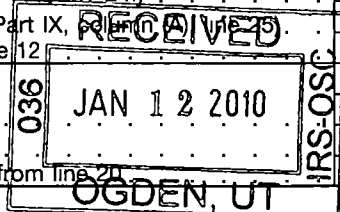

Provide programing and coordination of leadership activitiles at state conferences and meetings for the student members of Virginia FCCLA and their teachers. A minimum of four leadership conferences/meetings are scheduled annually for VA FCCLA members with registration and coordination provided largely by Alumni & Associates, working cooperatively with the student leadership team for VA FCCLA and their Board of Directors. Approximately 1200 students and 400 advisers participate annually in these leadership training meetings.

Provide coordination services and all travel arrangements for Virginia FCCLA student members and their teachers attending the annual national FCCLA Leadership Conference (conference location changes annually as determined by the national FCCLA organization). The 2009 conference was held in Nashville, TN. 251 students and teachers from Virginia FCCLA attended. Alumni & Associates arranged hotel accommodations, travel, several group meals, educational group tours, conference registration, and state meeting details for the Virginia participants.

The governing body of Virginia Alumni & Associates meets two times annually to plan coordination of the organization's program activities described above. Three members of this executive board attend the national FCCLA Leadership Conference each year to provide the coordination services for the state delegation. The expenses of this governing body's planning meetings and national meeting attendance/participation annually comprise the third and final program service category for Alumni & Associates.
