Organization also started a riparian restoration project on private lands with governments grants that will benefit the whole watershed.

ENLC completed various tasks outlined by the Bureau of Land Management, U.S. Department of Interior, to compile data that is essential to the determination of the restoration efforts that are needed on public lands including determination of watershed health on public lands. ENLC also completed tasks for the U.S. Forest Service that were needed prior to the Forest Service implementing restoration projects.
