Wild Rose Hospital's mission is to "provide superior services to improve the health of those we serve " In pursuit of its primary exempt purpose of providing inpatient and outpatient hospital and clinic services to the Waushara County area, Wild Rose Hospital provides medical care and other financial support through various programs that are designed, among other matters, to enhance the health of the community Wild Rose Hospital believes it has a special duty to meet the needs of the poor, indigent, and medically underserved in the communities and surrounding areas They have provided care to all patients without regard for the ability to pay Wild Rose Hospital actively provided or participated in the following community-based activities and programs - General health education services such as health fairs- Provided health information on the Corporation's web site and through health related publications distributed at no charge- Diabetes education and support group and balance training (physical therapy)- Hosted self-help and wellness programs such as AA, Al-Anon, Diet- Blood pressure screenings, cholesterol testing and school-based testing- Guidance, referral and enrollment assistance for public medical programs and other family support assistance- Discounted or free medical supplies and equipment to those unable to pay- Hosted five blood drives and encouraged employee participation- Contributed to the education of student nurses and other health care professionals- Provided first aid for community sporting events- Participated in work health education programs through PCIP- Made cash contributions to support community services and events- Provided meeting rooms to community groups at no charge Wild Rose Hospital operates an emergency room that is open to all persons regardless of ability to pay It has an open medical staff with privileges available to all qualified physicians in the area The majority of the board of directors is comprised of independent individuals who are representative of the community Consistent with Wild Rose Hospital's mission, care is provided to patients regardless of their ability to pay, including providing services to those persons who cannot afford health insurance because of inadequate resources or those who are underinsured Wild Rose Hospital gives discounts from established charges to self-pay patients without regard to ability to pay and considers these discounts a part of its community benefit Health care services to patients under government programs, such as Medicaid, are also considered part of Wild Rose Hospital's benefit provided to the community since a substantial portion of such services are reimbursed at amounts less than the cost of providing care Patients who meet criteria for charity care, generally based on federal poverty guidelines, are provided care without charge or at a reduced rate Eligibility for charity care is determined based on qualifying criteria as defined in Wild Rose Hospital's charity care policy and from applications completed by patients and their families In 2009 over 275 accounts received charity care with a total cost of over \$202,000
