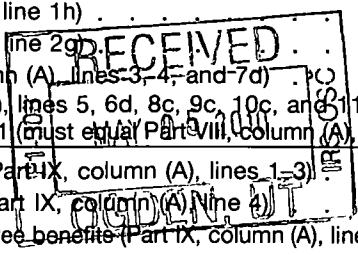

Provided tuition, room and board and school expenses for 36 poor students (who were selected based on excellent academic achievement in primary school) to continue their education at Ekitangaala and Shammah secondary schools. High school is not free. High schools are so few and far between that a student has to room and board at the school since home is too far away for daily commute. The yearly school fee nearly matches the family yearly income thus high school is not possible for these children without our help. Existing high schools in Uganda are extremely over crowded with very poor facilities. The curriculum is deplorable. Few teachers have more than one year of college training. We have reviewed the available high schools in the district to send our sponsored students to and have found the best schools.
