THE ORGANIZATION PROVIDED DECENT, SAFE, SANITARY AND AFFORDABLE HOUSING TO 47 RESIDENTS: 74% BETWEEN AGES 62-80 AND 26% BETWEEN AGES 81-95. MANY RESIDENTS UTILIZED THE ON-SITE NEIGHBORHOOD NETWORK (COMPUTER) CENTER WITH HIGH-SPEED INTERNET ACCESS, WEEKLY TUTORING AND COMPUTER CLASSES. RESIDENTS ALSO USED THE NEARBY GRANITE REEF SENIOR CENTER FOR APPLICATIONS/ASSESSMENTS FOR QUALIFYING SOCIAL SERVICES. SOCIAL WORKERS AT THE SENIOR CENTER ALSO ASSISTED RESIDENTS WITH BENEFITS, ENTITLEMENTS, INSURANCE, ETC.
