Arroyo Vista provides a full complement of primary and preventive healthcare services, radiology, mammography, dentistry, optometry, laboratory, ultrasound, pharmacy, and health education services for the entire family. The services are directed to the five stages of the human life cycle: perinatal, pediatrics, adolescents, adult including women's health, and geriatric medicine. Free health promotion and disease prevention services are also provided, consisting of annual children and adult health fairs, daily blood pressure, dental and vision screenings, pregnancy tests, childhood immunizations, and influenza vaccines. It is accredited by the Joint Commission on Accreditation of Healthcare Organizations since 1994, and is the most comprehensive Federally Qualified Health Center safety net provider in its service area. From its humble beginnings in 1981 as a small storefront clinic, it has grown to a network of four health centers and a mobile clinic with over 120,000 patient visits in 2009.
