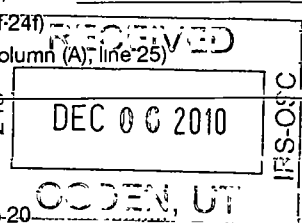

PEARCE WAS SLATED FOR CLOSURE BY TEA LAST YEAR DUE TO CHRONIC LOW PERFORMANCE AND WAS GIVEN ONE YEAR BY THE EDUCATION COMMISSIONER TO IMPROVE STUDENT OUTCOMES. THE PEARCE FAMILY RESOURCE CENTER WAS LAUNCHED IN JANUARY 2010. DESPITE BEING OPEN FOR A SHORT PERIOD OF TIME, THE FRC STAFF HAS ALREADY LAUNCHED A MENTORING PROGRAM, PARENT TRAINING SERIES, AND CASE MANAGEMENT SERVICES FOR FAMILIES. THE CENTER ITSELF DOES NOT DISTRIBUTE FUNDS OR GIVE DIRECT SERVICES (WITH THE EXCEPTION OF SCHOOL UNIFORMS, BUS PASSES, EMERGENCY FOOD GIFT CARDS AND IMMUNIZATIONS). INSTEAD, THE CENTER OPERATES BY CONNECTING CLIENTS TO RESOURCES THROUGH REFERRALS AND APPLICATION ASSISTANCE. THE SOCIAL WORKERS HELP ADDRESS
