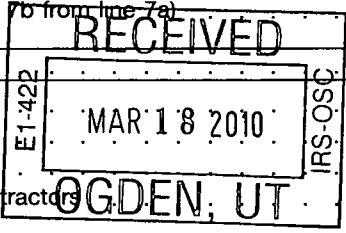



Birthright also utilizes community resources and makes professional referrals. Guidance is offered in helping a mother plan for her child's future, and should she choose to give her baby an adoptive home, she is referred to licensed adoption agencies. Our program is designed to build hope and self-esteem. For as long as the new mom feels the need, she remains part of the Birthright family. All of the expenses of the organization relate to such exempt purpose.
