To support the Micanopy Library and enhance its resources, promote literacy in our community, encourage a life-long search for knowledge and enjoyment of reading, and foster a love of reading in Micanopy children.

First Program Service Accomplishments Description

Description

after-school, one-on-one homework tutoring program for low-income, at-risk children in the Micanopy area, starting in the fall of 2003. From serving six elementary school children twice weekly with volunteer tutors, it has grown to serve 30 school children four days a week with up to four and a half hours daily of one-on-one tutoring. We have a paid Assistant to the Director. MCEE partners with the University of Florida for students to tutor from the Federal Work-Study Program that contributes 75% of their salary. Children's attendance, completion of homework, and attitude are recorded daily, and conferences are held with the children's parents and teachers. Report cards are reviewed and provide progress benchmarks. All of our children were failing or nearly failing when accepted into the program. On their recent report cards 60% of the elementary school students and 43% of the middle and high school students had a "B" average or above. Every child but one made a better than "C" average. The Program Director and all administrative staff are volunteers and all supplies are donated.
